

#### **OPENING SESSION**

#### Rola Dashti

Rola Dashti is the Executive Secretary of ESCWA and is a leading Kuwaiti economist and long-time champion of women's rights and democratic reform. She served as member of the Supreme Planning Council in Kuwait. From 2012 to 2014, she was Minister for Planning and Development and Minister of State for Parliamentary Affairs and played a pivotal role in advocating for a decree to allow Kuwaiti women to vote and run for parliamentary elections. In May 2009, she and three others became the first women to be elected to the Kuwait parliament. Ms. Dashti has held key positions in research and development institutions, such as the Kuwait Institute for Scientific Research, and has worked for major national and international financial and development institutions, such as the National Bank of Kuwait and the World Bank. She is a regular contributor to regional and international policy forums on global governance, economic development and integration, democratization, and women's empowerment. Ms. Dashti won the North-South Prize of the Council of Europe for 2010 together with Mr. Mikhail Gorbachev. She also received the Clinton Global Citizens Award for 2009, the Vital Voices Global Leadership Award for 2006, and the King Hussein Humanitarian award for 2005. She is listed among the top 150 women leaders by Business Week, and among the world's 100 most powerful Arabs by Arabian Business. Ms. Dashti holds a doctorate degree in population dynamics from Johns Hopkins University in Baltimore, a master's degree in economics and finance from California State University, and a Bachelor of Science in agriculture economics from California State University.

#### Amina J. Mohammed

Amina J. Mohammed is the Deputy Secretary-General of the United Nations and was Minister of Environment of the Federal Republic of Nigeria from November 2015 to December 2016, where she steered the country's efforts on climate action, protecting the natural environment and conserving resources for sustainable development. Prior to this, she served as Special Adviser to Secretary-General Ban Ki-moon on Post-2015 Development Planning, where she was instrumental in bringing about the 2030 Agenda for Sustainable Development, including the Sustainable Development Goals. Before joining the UN, Ms. Mohammed worked for three successive administrations in Nigeria, serving as Special Advisor on the Millennium Development Goals, providing advice on issues including poverty, public sector reform and sustainable development, and coordinating programmes worth \$1 billion annually for MDG-related interventions. She is also an Adjunct Professor in Development Practice at Columbia University, and served on numerous international advisory boards and panels, including the UN Secretary-General's High-level Panel on Post-2015 Development Agenda, the Independent Expert Advisory Group on the Data Revolution for Sustainable Development, the Global Development Program of the Bill and Melinda Gates Foundation, the African Women's Millennium Initiative, Girl Effect, 2016 African Union Reform and the ActionAid International Right to Education Project. Ms. Mohammed began her 35-year career in the private sector with architects and engineers responsible for the project management of health, education and public sector buildings.

#### Muhammad Ali Tamim

Muhammad Ali Tamim is the Deputy Prime Minister and Minister of Planning of the Republic of Iraq since 2022. He previously held several senior positions, including Acting Chairman of the General Authority for the Control of the Allocation of Federal Revenues (2023-2024), Minister of Education (2010-2014), and President of Kirkuk University (2003). Mohammed Ali Tamim has been a member of the Iraqi Council of Representatives for five terms since 2005, and has held numerous positions, including a member of the Council of Ministers' federal budget preparation committees for the years 2011, 2012, 2013, and 2014, and Chairman of the Parliamentary Finance Committee (2017-2018). He has made numerous contributions to the drafting of the Iraqi Constitution,

including serving as Deputy Chairman of the Constitutional Rewriting Committee (2020-2021). He holds a PhD in International Relations and a BA in Law. He has published approximately 24 research papers in various fields of law, political science, the history of international relations, history and society, and literary publications, in addition to academic research published in international journals.

#### **Ahmed Aboul Gheit**

Ahmed Aboul Gheit is the Secretary General of the League of Arab States since July 2016. He was Minister of Foreign Affairs of Egypt between 2004 and 2011. He previously served as the Permanent Representative of Egypt to the United Nations, between 1999 to 2004. He served as Egypt's Ambassador to Italy, Macedonia, San Marino and Representative to the Food and Agriculture Organization in Rome, between 1992 and 1996. He held the post of Chef de Cabinet of the Minister of Foreign Affairs of Egypt twice, between 1996 and 1999, and between 1989 and 1992, and was the Political Adviser to the Minister of Foreign Affairs between 1989 and 1990.

Prior to those duties, Aboul Gheit was Deputy Permanent Representative to the United Nations, Counsellor at the Permanent Mission of Egypt to the United Nations, Political Adviser to the Prime Minister of Egypt and Political Adviser to the Minster of Foreign Affairs of Egypt. He was awarded the French Legion d'Honneur, first rank in 2002. He holds a Bachelor's degree in economics from Ain Shams University (1964).

#### Noha El-Mikawy

Noha El-Mikawy is the Dean of the School of Global Affairs and Public Policy at the American University in Cairo. She is the former regional director of the Ford Foundation, Middle East and North Africa office (2012-2022). Between 2005-2012, Noha served as Team Leader for Governance at the UNDP Regional Center (based in Lebanon then Egypt), where she provided support on governance reform in Egypt, Tunisia, the Sudan, Somalia, Yemen, Jordan and Kuwait. Noha also served as policy advisor at the UNDP Oslo Governance Center in Norway, where she supervised UNDP's global project on governance assessments, organized international convenings on legal empowerment of the poor, and edited a UNDP-UN Women guidebook on gender-sensitive service delivery. Before 2005, Noha led comparative research on the political economy of MENA at the Centre for Development Research at the University of Bonn (Germany) and lectured on politics of the Middle East at the American University in Cairo, Free University of Berlin, and Erlangen-Nuremberg (Germany). Noha holds a Ph.D. and M.A. from the University of California, Los Angeles (USA) and has publications by reputable international publishers on institutional reform and governance in MENA.

#### Karim Haggag

Karim Haggag is a Professor of Practice at the School of Global Affairs and Public Policy at the American University in Cairo, and a non-resident fellow at the Belfer Center for Science and International Affairs, Harvard Kennedy School of Government. He is a career Egyptian diplomat with over 25 years of serve in the Egyptian diplomatic service. Throughout his diplomatic career, he has focused on Middle East regional security, arms control and non-proliferation, conflict resolution, and Arab-Israeli diplomacy. From 2011-2013 he was a visiting professor at the Near East and South Asia Center for Strategic Studies National Defense University in Washington DC. Ambassador Haggag is also currently a Senior Advisor at LYNX Strategic Business Advisors, Egypt's leading government relations and public policy consultancy. He is a graduate of The American University in Cairo, and has earned an MA in war studies from King's College in London.

#### Marwa Fatafta

Marwa Fatafta leads Access Now's policy and advocacy work on digital rights in the Middle East and North Africa (MENA) region. Her work spans a number of issues at the nexus of human rights and technology including content governance and platform accountability, online censorship, digital surveillance, and transnational

repression. She has written extensively on the digital occupation in Palestine and focuses on the role of new technologies in armed conflicts and humanitarian contexts and their impact on historically marginalized and oppressed communities. Ms. Fatafta is a Policy Analyst at Al-Shabaka: The Palestinian Policy Network, an advisory board member of the Tahrir Institute for Middle East Policy, and an advisory committee member for Bread&Net. She was a Fulbright scholar in the US and holds an MA in International Relations from Maxwell School of Citizenship and Public Affairs, Syracuse University. She also holds a second MA in Development and Governance from the University of Duisburg-Essen.

#### Hala Bsaisu Lattouf

Hala Bsaisu Lattouf has over 20 years of experience in the private sector, development and public sector work; she was the Minister of Social Development for several terms; prior to that she was the Office Director for Her Majesty Queen Rania Al Abdullah. She also worked with UNDP as head of the Poverty and Gender Teams and with the World Bank as a Project Director for a Tourism Project. In addition, she has experience working in Syria, Jordan, Yemen, Egypt and Palestine (West Bank and Gaza). She is currently the Managing Partner for AYA for Consultancy and Development. Hala started her career as FX currently dealer then as an analyst at the Ministry of Finance, working on the 1988 Jordan Debt Restructuring. She also worked at the Arab Bank, Head Office-Jordan as Credit Officer at the International Branches Department. Hala currently serves on the Board of Trustees for the Royal Society of Fine Arts, the Baptism Development Foundation (VC) the Royal Institute for Interfaith Studies, the Central Bank of Jordan, Jordan Deposits Insurance Cooperation, Jordan Education and Women Empowerment NGO (JEWELS) and the American Center of Oriental Research (ACOR). She holds a Master's in Accounting and Finance from the London School of Economics and Political Science (LSE), and a Bachelor of Science in Economics and Applied Statistics from the University of Jordan.

#### **Mahmoud Mohieldin**

Mahmoud Mohieldin is a distinguished economist with over 30 years of expertise in international finance and development. He is the UN Special Envoy on Financing the 2030 Agenda for Sustainable Development and leads a group of prominent experts appointed by the UN Secretary General to promote solutions for resolving the debt crisis. He has served as the UN Climate Change High-Level Champion for COP27. Previously, Mahmoud Mohieldin was an Executive Director at the IMF, held leadership roles at the World Bank and was Egypt's Minister of Investment (2004–2010). He has also held prominent academic positions, including Professor of Economics at Cairo University, and has received honorary doctorates from renowned universities. Mahmoud Mohieldin holds a Ph.D. in Economics from the University of Warwick and has authored several books and numerous articles in leading journals in the fields of economics and development.

#### **Nizar Yaiche**

Nizar Yaiche served as the Minister of Finance of Tunisia in 2020. An internationally recognized expert, he holds a distinguished position within the global executive leadership of a preeminent advisory firm, ranking among the largest worldwide. #### Amr Aljowaily

Ambassador Amr Aljowaily is an Egyptian diplomat, academic and writer with 34 years of professional experience. He currently holds the post of Assistant Foreign Minister for Multilateral Affairs and International Security. As an international civil servant, he held the post of Strategic Advisor to the Deputy Chairperson of the African Union Commission (Partnerships and Stakeholder Engagement) in Addis Ababa. As an academic, he was visiting faculty at the United Nations Institute for Training and Research (UNITAR) Multilateral Diplomacy Program (2014-2024), and Diplo Academy and Foundation (2007 to 2024), and previously at the American University in Cairo including the School of Global Affairs and Public Policy, as well as Board Member of the Institute for Diplomatic Studies (1994-1996). As an Egyptian diplomat, his postings included Belgrade, New York, Geneva and Washington, DC. At the Foreign Ministry, he served as Deputy Assistant Foreign Minister for United Nations Affairs, member of the Cabinets of the Minister and First Undersecretary and the departments of multilateral political and economic issues. From 2010 to 2015, he directed UN Women's systemwide and interagency coordination efforts, holding key positions such as Chair of the UN Development Group Task Team for Gender Equality. Earlier, he was Deputy Executive Director at UNIFEM and the UN Resident and Humanitarian Coordinator in the Maldives. She is a member of the Syrian Women Advisory Board a body part of the UN Special Envoy's efforts for the Syrian-owned and led political process. She works on supporting local peacebuilding efforts, promoting gender equality, and enhancing local participation through research and advocacy. He was elected to the Jordanian Lower House of Parliament in the 18<sup>th</sup> Parliament. His parliamentary work included membership of the National Guidance and Media Committee. Additionally, he was part of the National Parliamentary Bloc. In his earlier political career, Khaled Mahmoud Al-Bakkar also served in the 15<sup>th</sup> Lower House of Parliament. Beyond his political career, Khaled Mahmoud Al-Bakkar is deeply involved in civil society. He serves as the President of Waqas Center for Rehabilitation and is an active member of the Jordanian Businessmen Association, where he advocates for economic development and social welfare initiatives. With a strong background in both healthcare

administration and legislative experience, His Excellency Khaled Mahmoud Al Bakkar brings a unique perspective to his role as Minister of Labour. His work continues to focus on enhancing Jordan's labour market, promoting economic resilience, and addressing the needs of workers across the country.

#### **Fayçal Bentaleb**

Fayçal Bentaleb is the Minister of Labor, Employment and Social Security of the People's Democratic Republic of Algeria.

#### Najwa bint Abdulrahman Al Thani

Najwa bint Abdulrahman Al-Thani – Undersecretary at the Ministry of Labour – State of Qatar.

Najwa bint Abdulrahman Al-Thani is the Undersecretary at the Ministry of Labour in Qatar (appointed December 2024), responsible for strategically enhancing and executing policies, regulations and systems related to Qatar's labour market. She is also the Vice Chairman of the Board of Directors for the Workers' Support and Insurance Fund, and the General Secretary for the National Committee for Combating Human Trafficking. Furthermore, she chairs the National Minimum Wage Commission and sits on the National Workforce Planning Committee and the Board of Directors for Qatar Manpower Solutions Company – Jusour.

Her career spans diverse roles in strategic communications, international relations, and human rights advocacy. Coming from the human rights world, Al-Thani started her career at the National Committee for Human Rights in Qatar (NHRC), where she served as Director for International Cooperation, responsible for monitoring and enhancing Qatar's international human rights commitments. She headed the coordination and cooperation with international and regional mechanisms, ensuring the execution of consistent relevant reporting, and enhancing strategic participation internationally. She then served as the Director of Communications at the Supreme Committee for Delivery & Legacy (SCDL), the organization responsible for Qatar's preparations for the FIFA World Cup 2022. During her tenure, she collaborated with local and international stakeholders, including governments, NGOs, and international organizations, ensuring the tournament's objectives aligned with global dialogues and priorities. Before assuming her current position at the Ministry of Labour, Al-Thani held the role of Assistant Undersecretary for Migrant Affairs, where she played a key role in supporting high-level decision-making and facilitating strategic initiatives for the migrant labour sector.

Al-Thani's educational background includes a Bachelor of Science (BSc) in Communications from the School of Communications - Northwestern University (NU) with a Certificate of Middle Eastern Studies, a Master of Science (MSc) in Global Governance and Diplomacy from The University of Oxford - Department of International Development (ODID). #### Fadi Makki

He is a behavioural economist who pioneered the application of behavioural economics and "nudge" concepts in the Middle East. He previously served as Partner and Director at Boston Consulting Group (BCG) in Washington, DC, where he co-led the firm's Behavioral Science Lab. In 2016, he founded and led two of the region's first behavioural science units: Nudge Lebanon and B4Development, the behavioural insights unit of the Supreme Committee for Delivery and Legacy for the FIFA World Cup Qatar 2022. In this role, he integrated behavioural insights into the planning and delivery of the tournament. Dr. Makki has since supported the establishment of over a dozen behavioural science teams globally—across governments, the private sector, NGOs, and international organizations—and has led more than 150 behavioural experiments across a wide range of fields including sports, health, sustainability, education, inclusion, compliance, and the rule of law. In 2021, he was named one of the world's 50 most influential individuals navigating disruption (Agile 50) by the World Economic Forum and Apolitical. He served as Co-Chair of the World Health Organization's Technical Advisory Group on Behavioral Insights for Health, and from 2016 to 2018, was a member of the World Economic Forum's Future Council for Behavioral Science. Dr. Makki has published extensively on behavioural science, economic and trade policy, public sector reform, health, education, and social inclusion. He has held academic positions as a research fellow, adjunct professor, or lecturer at institutions including Cambridge University, Institut Universitaire de Hautes Études Internationales (Geneva), Georgetown University, American University of Beirut (AUB), Hamad Bin Khalifa University (HBKU), Lebanese University, and Université Saint-Joseph (USJ). His earlier professional experience includes leadership roles at Cisco, Booz Allen Hamilton, and Booz & Co., where he guided strategy, restructuring, digital transformation, and change management initiatives for both public and private sector clients across the Middle East. #### **Khaled El Taweel**

#### Ali El-Kekli


